# Recall | ARConnect is setting an ECHPLT at 97<sup>th</sup> percentile of preliminarily selected locations




## Threshold and Impacted Tranches



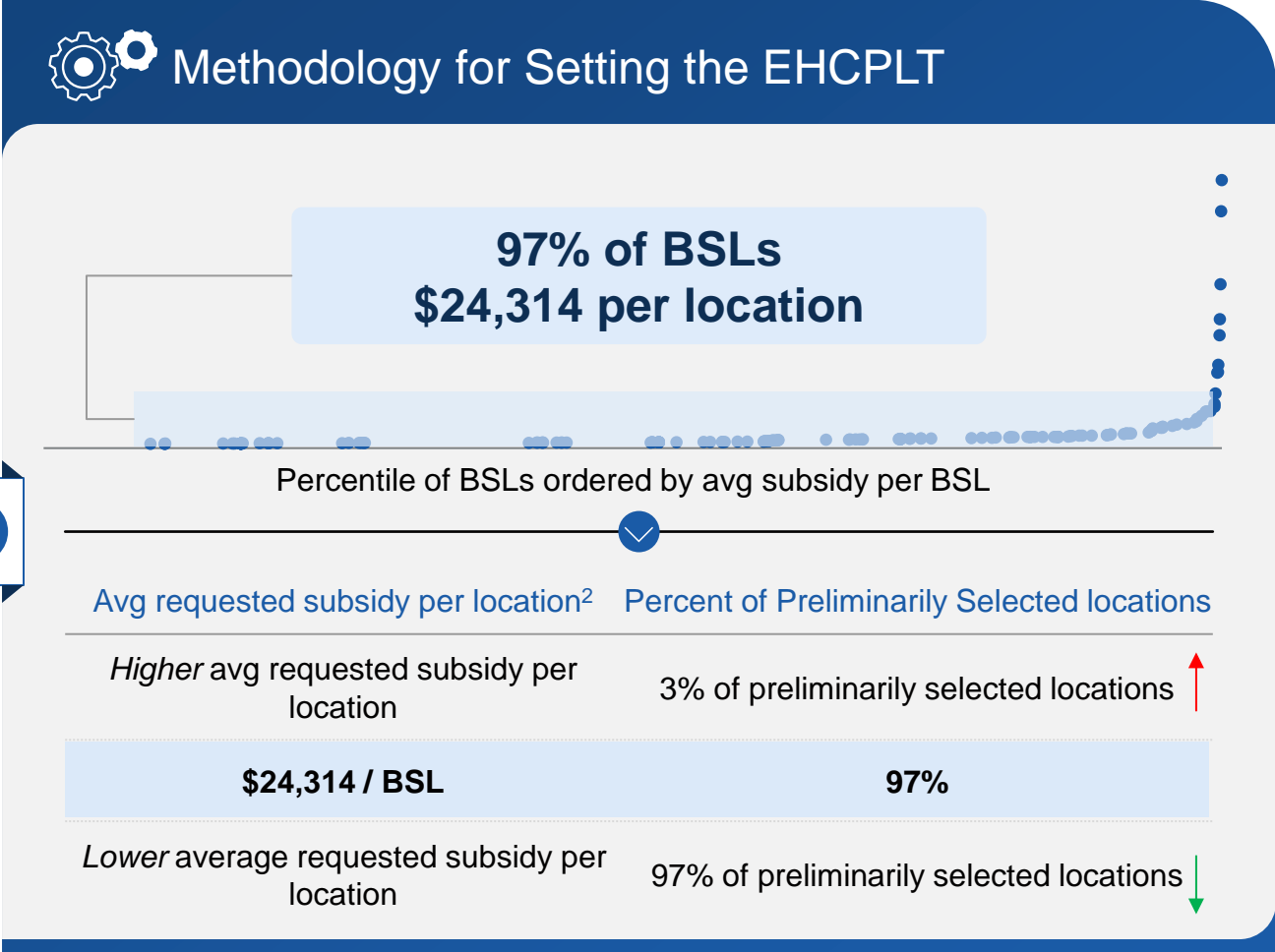
ARConnect is setting an Extremely High Cost per Location Threshold based on the average requested subsidy per location at the **97th percentile** of all preliminarily selected locations<sup>1</sup>



This equals an EHCPLT of **\$24,314**



The EHCPLT will be applied to **bids preliminarily selected in Tranche-3**, as this round of bidding did not have a pre-existing cost threshold, and measured against the **average per-location subsidy amount**, not the total

## Recall | Modifications to impacted bids in Tranche-3



You may modify your impacted bid(s) in three ways to bring the average subsidy per location below the EHCPLT:

- 1 Reduce the subsidy request such that the average subsidy per location is below the EHCPLT **(Required)** AND
- 2 Remove high-cost BEAD-eligible locations **(Optional)** AND/OR
- 3 Change the technology type **(Optional)**



Note that removing high-cost locations and changing the technology type are optional modifications. You are, however, required to lower the subsidy request such that the average subsidy per location is below the EHCPLT








If you choose to make no modifications, ARConnect will rescind the preliminary selection(s)








Additional technical assistance regarding the exact mechanism to modify impacted bids will be released at a later date

## Tab | Overview

*If you have any bids in your portfolio impacted by the EHCPLT, you will receive an email and accompanying "Impacted Bid" document. This document will have tabs titled "Overview" and "All Impacted Bids", as well as a tab for each bid impacted by the EHCPLT in your portfolio.*

*Please first review the bid modification process by reading the detailed instructions in the "Overview" tab*

Overview
<p>This form is meant to streamline the process for modifying your bid(s) impacted by the EHCPLT. As specified in the supplemental guidance issued by ARConnect, you have two options to modify your bid(s) to ensure that the average subsidy per location is below the EHCPLT:</p> <ol style="list-style-type: none"><li>1. <b>Remove high-cost locations AND lower the subsidy request</b> based on the high-cost locations removed from the bid</li><li>2. <b>ONLY lower the subsidy request</b> such that the average subsidy per location is below the EHCPLT. By exercising option 2, please note you will still be obligated to serve all locations in the original bid</li></ol> <p>Please note that <b>for both options, you may change the technology type of your project(s)</b> to propose a mix of fiber and non-fiber technologies to bring the subsidy per location below the EHCPLT. If you do not exercise either option for a bid, ARConnect will rescind the preliminary selection.</p> <p>This form has two sections:</p> <p><b>All Impacted Bids</b></p> <p>This tab provides the list of all Tranche-3 bids impacted by the EHCPLT. For each impacted bid, you will see the number of locations, original subsidy request, and the original average subsidy per location. There is also a column to indicate whether you will elect to modify a bid using the options listed above.</p> <p><b>Location Rosters</b></p> <p>Each of your impacted bids will have its own tab in the Location Rosters section. The tab, labeled with the bid name, will contain the list of Location IDs in the bid. There is a column called "Remove?" where you will indicate whether you would like to keep the location in the bid or remove it. Each location is set to "Keep" by default.</p> <p>Please read through the following instructions carefully to proceed with modifying your impacted bids. Note the only columns you will be able to edit have a light blue header.</p> <p><b>Step 1</b> - Review the list of impacted bids in the All Impacted Bids tab. If you would like to modify the bid, select <b>"Y"</b> from the drop down menu in column F. If you do not wish to modify the bid, select "N." If you do not wish to modify a bid such that its average subsidy per location is under the EHCPLT, the bid will be resinded</p> <p><b>Step 2</b> - <b>For each bid marked "Y" in column F</b>, review the list of locations in the corresponding tab in the Location Rosters section. If you would like to remove the location, simply select <b>"Remove"</b> from the drop down menu in column I. Please note that you will need to conduct your own review using the tools at your disposal to determine which high-cost locations to remove</p> <p><b>Step 3</b> - Return to the All Impacted Bids tab, indicate whether you will <b>change the technology type from the drop down menu in column G</b>, and input a <b>new subsidy request for each bid you wish to modify in column H</b>. Note that columns G and I will auto-populate with the new number of locations and the new average subsidy per location respectively. If the new average subsidy per location is still above the EHCPLT, the cell will be highlighted <b>red</b>. ARConnect will <b>NOT accept</b> any modified bids where the new average subsidy per location is <b>still above the EHCPLT</b>. Please also note that ARConnect will <b>rescind the preliminary selection for any bid marked "N" in column F</b>. After you have completed steps 1-3, column K will provide the <b>bid status based on your chosen modifications</b>. Once you have made modifications to each bid, you can review the impact of the changes on each bid's average requested subsidy in the "All Impacted Bids" tab

The "Bid Status" column will indicate the outcome for each bid based on its current modifications

Bid Status	Status Definition
No Modifications	No modifications have been made, and the preliminary selection will be rescinded.
Further Modifications Needed	This bid is still above the EHCPLT and requires further modification.
Modifications Accepted	Congratulations, this bid is now below the EHCPLT and may be preliminarily selected.

Once you have made your intended modifications and are satisfied with the status of each bid, email the entire completed "Impacted Bids" document to [ARGrants@mbakerintl.com](mailto:ARGrants@mbakerintl.com) by Tuesday, June 3 at 10 pm CT. These modifications will then be resent to you as a revision request in the Grantor Portal for final confirmation
